The meeting was called to order by George H. Little, Chairman at 3:10 PM. Roll call was taken and a quorum was present.

The minutes of the December 3, 2003 meeting were read and approved as corrected, motion by Frank Maisano, second by Hal Richmond.

Correspondence read consisted of four (4) e-mails, two (2) letters from the International Organization office, and a thank you letter from the Fire Marshal's Association on the chapters work in getting AFCI's into Michigan in the 2002 NEC adopted.

Treasurer, Jim Chase gave the financial report and it was approved as presented, motion by Dave Burns, second by Hal Richmond.

Spring Program Chairman, Ed Harris is excused due to recovering from surgery. Mr. George Little gave an explanation of this month meeting programs. The first presentation will be by Mr. David Williams on the Michigan Part 8 Rules. The balance of the program on the 2002 NEC will be presented by Mr. Michael Johnston, Director of Education, of the International's Texas office. The complete program will satisfy the Michigan license code update requirements of PA 217 and apply fifteen (15) hours of technical for PA 54.

There will be a meeting with Mr. Ed Lawry before the June meeting to review the Chapter's budget requirements for the 2006 meeting. Paul Knapp called every ones attention to the new banner he had made that will advertise 2006 Section meeting in Michigan. Plans are to show banner at our booth at the 2004 and 2005 Western Section meetings.

Under unfinished business: Secretary Darrick Whitaker read a letter from the Mechanical Inspectors Association of Michigan requesting a person to become the Chapters representative to their organization. Jim Chase reported on the Electrical Inspectors school held in January. There were twenty-nine (29) attendees. The instructor costs were higher than in the past, costs are going up every year. Frank Maisano attended and expressed that he felt the school was of great value. David Sniderman stated that the cost to some one should be ten dollars per credit hour. Bob Nalbach asked if a second one could be held at the Grand Rapids area. Bob Nalbach made a motion to charge ten dollars per credit hour, second by Mel Kooiker. Discussion: John Danic stated that the education committee should work on pricing, Dave Burns agreed that it should go through that committee. Vote three (3) for, eight (8) against motion failed, issue goes to the education committee.

Under new business: A letter from the international office questioning if we would provide the membership fee for past Secretary Robert Eix. Motion by Jim Chase to pay fee, second by Mel Kooiker. Motion passed. A motion by Mark Shapiro to purchase a full-page ad in the 2004 Western Section bulletin, second by David Sniderman. Motion passed. John Hartigan stated we missed an opportunity to tie the update requirement at this meeting to adding new members. He felt that non-members should pay thirty (30) dollars more. David Williams made a motion to charge non-members fifty (50) dollars more per meeting, second Hal Richmond. Discussion: Frank Donovan asked if we knew how many attending this meeting were no-members, Mark Shapiro stated he felt that fifty (50) dollars was to high, and made a motion to admen the motion on the floor to charging thirty (30) dollars per meeting, second by Dave Bums, discussion amendment, Frank Maisano said he felt that fifty (50) was not out of line Don LaBrenz TI agreed with Frank. Amendment vote, two for, and eight against Motion failed. Vote on David Williams's motion to charge an additional fifty (50) dollars to non-members, nine for, and one against. Motion passed. Paul Knapp asked for comments on the banner. Hal Richmond requested a copy of the flyer to add to the web site.
