Previous Minutes: David Williams, Secretary, presented the Minutes of the June, 2023 Board of Directors meeting. Pat Falzon made a motion to approve the minutes as presented, seconded by Bert Gale. **The Motion Carried.**

Correspondence: Received correspondence from Brian Carter stating he is retiring at the end of the year. He stated he is resigning from the Board of the Board of Directors

Presidents Report: President Cleveland reported on Brian Carter's resignation and asked about a recognition. State of Michigan Report: Lance Ash, State Electrical Chief, the First Draft for the 2023 Michigan Electrical Code was approved on July, 31, 2023. The Public hearing date has not been determined. The draft rules for the MRC have not been approved at this time. There were over 50 proposals to remove the electrical sections from the Michigan Residential Code. Inspector Re-registration: To renew your inspector registration after 5/3/2023 you must submit all certificates of completion to the Bureau to renew your inspector.

Registration Secretary Report: Bryan Thomas, Registration Secretary, No report at this time. There is a motion by Bert Gale and supported by Lance Ash to purchase a new Laptop, Microsoft Office, Acrobat Pro and accessories for up to \$2,500.00. **The Motion Carried.**

Unfinished Business: There was a motion by Lance Ash and supported by John Stoudt to increase the Secretary's Annual Compensation to \$5,000.00 and provide a room at the meetings. **The Motion Carried.**

New Business: Ed Rosette asked on behalf of RECI to share the IAEI Michigan Chapter membership names and email address for educational opportunities. There are concerns about it reducing our attendance at future meetings. We are checking with the IAEI to see if we have the right to give that information without our members consent.
